Dean's Measure No. 8/2020 The possibility of placing employees and students in quarantine in facilities of the FFPW USB

The Dean of the FFPW USB, in connection with the Rector's Decision No. 4 On the current development of the coronavirus epidemic and the resulting obligations to issue own decision to allocate available quarantine space for students and staff, issues this Dean's Measure No. 8/2020 The possibility of placing employees and students in quarantine in facilities of the FFPW USB.

- The FFPW USB allocates rooms in the Building of technical facilities of the FFPW USB ("Little House") equipped in accordance with par. 5 letter b of the Rector's Decision No. 4 On the current development of the coronavirus epidemic (hereinafter referred to as the "Decision") for accommodation of employees and students who do not have available other accommodation facilities in the Czech Republic and they are given a 14-day quarantine upon their return from abroad.
- 2. In the case of insufficient capacity allocated for the quarantine needs within the Building of technical facilities of the FFPW USB ("Little House"), the Dean of the FFPW USB, respectively his representative reserves the right to extend these capacities with the necessary rooms and beds. Existing tenants of accommodation capacities in the Building of technical facilities of the FFPW USB ("Little House") will be offered alternative accommodation within the FFPW USB buildings.
- 3. Placing of students and employees of the FFPW USB in quarantine is governed by instructions of the Dean of the FFPW USB, resp. his representative after discussing the matter within the Crisis Staff of the FFPW USB.
- 4. For staff and students placed in the quarantine applies relevant Measures of the Rector, the Dean and other methodical instructions issued in connection with the development of the coronavirus epidemic: http://www.frov.jcu.cz/cs/covid-19
- 5. I appoint Lucie Kačerová (Officer for Ph.D. study and foreign affairs) to be the person who will take care of employees and students of the FFPW USB placed in quarantine in the Building of technical facilities of the FFPW USB ("Little House"). The costs associated with the quarantine of an employee or a student will be covered by the FFPW USB (e.g. accommodation, personal protective equipment, basic long-lasting food equipment before the quarantine begins, etc.). The carer shall ensure for quarantined residents the provision of information necessary to comply with all relevant measures and guidelines related to the coronavirus epidemic. The carer is the member of the Crisis Staff of the FFPW USB.

This Dean's Measure is valid until its cancellation.
