## **Explanatory notes:**

State Final Exam (for Bachelor's and Follow up MSc studies); State Doctoral Exam (Ph.D.)

The abovementioned remunerations apply only to those publications that are issued by the FFPW USB. These are primarily funded from projects to support these activities. In the event of their absence and after the approval of the Dean's collegium, the costs associated shall be covered from 50% by the relevant part of the FFPW USB (according to the author's share,

unless the directors of the parts make other arrangement) and from 50% by the office of the Dean of the FFPW USB.

- <sup>1)</sup> External person a person employed on the Agreement to complete a job / Agreement to perform work (DPP/DPČ) or a person without employment relationship at the FFPW USB.
- <sup>2)</sup> The amount of the royalty in mentioned range is proposed by the Vice-Dean for S & R. The Vice-Dean for S & R also proposes a remuneration to the editor, as well as to the opponents for their expert opinions and language proof reading. In the case of publishing updated editions, royalties and opponent opinions may be further reduced. The distribution of the remuneration to the individual authors is proposed by the leader of the author's team.
- The way of payment of travel expenses incurred in carrying out the above mentioned activities must be clearly specified in advance in the text of the Agreement to complete a job / Agreement to perform work (DPP/DPČ). Only those who submit a completed travel order with all the requisites are entitled to the refund of travel expenses.
- <sup>4)</sup> It is calculated in such a way that for 1 hour of a lecture or an exercise, there is 1 hour of preparation. The amount of the remuneration in that range is suggested to the Registrar of the faculty by the Vice-Dean for study affairs.
- <sup>5)</sup> Possible travel expenses for examining students in every subject can be claimed for a maximum of 6 times. The amount of the remuneration in mentioned range is suggested to the Registrar of the faculty by the Vice-Dean for study affairs.

<sup>6)</sup> Vice-Dean for External Relations proposes the amount of royalties in that range.

Any exceptions are decided by the Dean on the basis of a written request. This measure cancels the Dean's measure No. 16/2018.
