Dean's Measure No. 23/2021 Price list of payments for extraordinary and above-standard administrative acts provided to students and graduates of the FFPW USB, or other persons

- 1) I hereby issue a price list of payments for administrative acts provided to students and graduates of the FFPW USB, or other persons. The price list follows the USB Quaestors' Measure No. K 5 of 1st October 2004 and the Supplement K 13 of 2006.
- 2) In case of uncertainty whether it is an administrative act within the services provided in connection with full-time study in an accredited study program, or it is an abovestandard unclaimable act, the Vice-Dean for Study Affairs of the Faculty decides on the payment.
- 3) The Dean of the Faculty may, in justified cases, waive payments for extraordinary and above-standard acts. This applies in particular to fees associated with habilitation and professorship proceedings.

This Measure will become effective on 1st September 2021.

After the entry into force of this Measure, the Dean's Decision No. 21/2011 is cancelled.
