Measure of the Dean No. 28/2018

Reimbursement of travel and subsistence expenses for foreign co-workers and guests at the FFPW USB

Foreign co-workers and guests (hereinafter collectively referred to as "guests") come to the FFPW USB to realize projects of bilateral or multilateral cooperation or sub-projects aimed at sharing infrastructures or other projects, for which implementation the FFPW USB received funds and a specific budget directly intended to support the travel activities for arrival of these co-workers and guests. This measure regulates the conditions for reimbursement of the travel expenses of guests associated with it.

- 1) The measure on the reimbursement of travel and subsistence expenses connected with the implementation of above mentioned projects at the FFPW USB, applies only to the guests who do not get paid demonstrably the travel and subsistence expenses during their stay at the USB by their home institution.
- 2) The guests do not become employees of the FFPW USB.
- 3) Foreign co-workers and guests may be for the purposes of this Measure all categories of workers and students, if they are members of the research team of the project or have the opportunity to realize their individual project within the projects aimed at sharing of infrastructures.
- 4) The FFPW USB may reimburse a part or all of the costs associated with hosting. Reimbursement of funds to cover travel expenses of visiting guests at the FFPW USB primarily follows the applicable legislation, the budget and rules for spending the budget of the source from which travel expenses are reimbursed.
- 5) The specific scope of the guest's travel and subsistence costs is always specified in the hosting agreement. The part of the contract is a guest statement that travel and subsistence costs are not covered by another source. The example of the hosting agreement in the Czech language and English are annexes 1 and 2 to this Measure.
- 6) Reimbursement of travel and subsistence expenses will be provided to the guest up to the amount specified by the respective terms of the grant or other programs.



- 7) If the amount of travel and subsistence expenses is not set by the relevant terms of the grant or other programs, the following payments shall be made as follows:
 - a) Accommodation (max. up to EUR 45 / night) - specific amount is specified in the hosting agreement.
 - b) Meal allowance (max. up to EUR 25 / day) - specific amount is specified in the hosting agreement.
 - c) Use of the means of mass transport: The reimbursement will be set at the actual cost of the transport, based on the presentation of a tax document (ticket, flight ticket) or its copy, up to the limit stated in the hosting agreement.
 - d) Use of the guest's private vehicle: The reimbursement will be set at the basic compensation for the use of the road motor vehicle and the multiple of the average price of the fuel and the amount of fuel consumed. The basic compensation for the use of the road motor vehicle and the average price of the fuel is regulated for the current year by a decree of the Ministry of Labor and Social Affairs issued for the purpose of providing travel reimbursements under the Labor Code. The resulting amount will be converted to EUR. The guest is required to submit following documents to set the reimbursement:
 - a copy of the vehicle's technical license with indicated fuel consumption;
 - a route plan including distance statement/ calculation (using Google Maps - route planner) from the place of residence / current location of the guest to the place of hosting in the Czech Republic.If the technical license does not include the consumption data, it is possible to submit a copy of the technical license issued in the Czech Republic for a vehicle of the same type with the same content of cylinders, or to present an official certificate of the manufacturer/importer of the vehicle about its consumption for combined operation.
- Compensation for the use of a private vehicle shall not exceed the limit specified in the hosting agreement.
- 8) Payment of reimbursement for the use of the private vehicle for the transport of the foreign co-worker (guest) to / from the Czech Republic is permissible if such a possibility is unambiguously allowed by the rules of the relevant project, which is used as the source of such expenses. The guest will confirm on a Declaration of Honour the use of the private vehicle for the transport to / from the Czech Republic, specifying the purpose of the journey. Examples of the Declaration of Honour in the Czech language and English are annexes No. 3 an 4 to this Measure.
- 9) The FFPW USB is not liable for any damages which the guest suffers or which are caused by the guest during the journey.
- 10) The Dean of the Faculty can decide about exceptions.
